23	(3) The Court OVERRULES with	nout prejudice all of plaintiff's Objections to
24	Defendant's Evidence [Docket No. 98].	
25	(4) The Court OVERRULES with	nout prejudice all of defendants's Objections to
26	Evidence [Docket No. 96], save for defendant's objection to expert opinion presented by plaintiff's	
27	witnesses, which the Court SUSTAINS.

1	Further, the Court ORDERS the parties to a mandatory settlement conference with	
2	Magistrate Judge Zimmerman, on October 10, 2008, at 9:00 a.m. The parties shall have present in
