A discovery dispute has arisen that concerns whether a certain document produced by defendant Podfitness, Inc. ("Podfitness"), bearing control number PF001014 contains information protected from disclosure by the attorney-client privilege and thus should continue to be redacted pursuant to the Order re Joint Letter issued by this Court on February 4, 2008.
