 28 ORDER TO SHOW CAUSE RE: DISMISSAL OF CLAIMS BY PLAINTIFFS  
 WHO FAIL TO SUBMIT CLAIM FORMS OR APPEAR AT FURTHER SETTLEMENT CONFERENCE  
 CASE NO.: 3:07-CV-01016 PJH

1 A Settlement Conference was held in this matter on February 1, 2012, before the  
2 Honorable Magistrate Judge Jacqueline Scott Corley. All plaintiffs who had not submitted a  
3 signed release form had previously been ordered to appear at the Settlement Conference by this  
4 Court's September 7, 2011 Order (1) Preliminarily Approving FLSA Collective Action  
5 Settlement; (2) Approving Notice to FLSA Collective Action Plaintiffs and Release Form; (3)  
6 Directing Dissemination of Notice to FLSA Collective Action Plaintiffs; and (4) Setting a  
7 Hearing for Final Approval of the Settlement. All plaintiffs were provided notice of the  
8 Settlement Conference and, in the event they did not submit a signed release form, of the  
9 requirement that they appear. However, with a single exception, all of the plaintiffs who did  
not submit a signed release form failed to appear at the Settlement Conference.

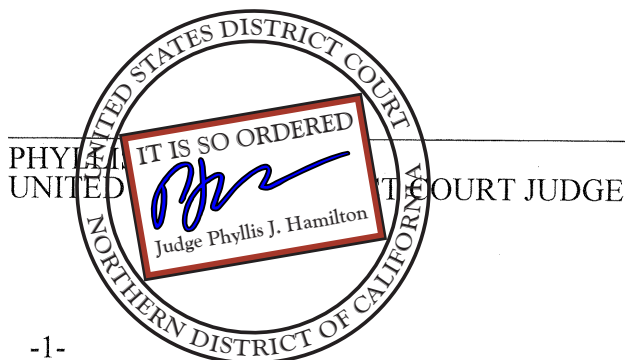
10 IT IS HEREBY ORDERED that any plaintiff who does not submit the enclosed release  
11 form signed by February 22, 2012, must appear at a Further Settlement Conference to be held  
12 before Magistrate Judge Jacqueline Scott Corley on February 28, 2012, at 3:30 pm in  
13 Courtroom F, on the 15<sup>th</sup> Floor of the United States District Court, located at 450 Golden Gate  
Avenue, San Francisco, California.

14 IT IS FURTHER ORDERED THAT ANY PLAINTIFF WHO FAILS TO SIGN AND  
15 SUBMIT THE ENCLOSED RELEASE FORM, OR FAILS TO APPEAR AT THE  
16 FURTHER SETTLEMENT CONFERENCE SCHEDULED FOR FEBRUARY 28, 2012,  
17 SHALL HAVE THEIR CLAIMS DISMISSED, WITHOUT PREJUDICE, AND SHALL NOT  
18 BE PERMITTED TO PARTICIPATE IN THE RECOVERY NEGOTIATED BY THE  
PARTIES IN THIS CASE.

19 IT IS FURTHER ORDERED that Simpluris mail a copy of this Order, as well as  
20 another release form, to each plaintiff who has not already submitted a signed release form.

21 **IT IS SO ORDERED.**
