1 On August 23, 2010, Plaintiffs filed a Motion for Reasonable Attorneys' Fees and  
2 Expenses Incurred on Appeal. Defendants' opposition brief is due to be filed on September 30,  
3 2010, and Plaintiffs' reply, if any, is due to be filed on October 7, 2010. On September 13, 2010,  
4 the Court ordered that the motion shall be decided on the papers. In an attempt to resolve the  
5 disputed issues short of Court intervention, the parties have agreed to participate in mediation.  
6 Accordingly, the parties stipulate that Defendants' opposition to Plaintiffs' motion shall be filed  
7 no later than January 7, 2011, and any reply may be filed no later than January 24, 2011.
