 21 Plaintiff, **LORENZO FOSSELMAN, Jr., CDCR No. P-13462**, a necessary and material
 22 witness in proceedings in this case **beginning on December 15, 2009, at 11:00 a.m.**, is confined
 23 at Kern Valley State Prison in the custody of Warden Kelly Harrington. In order to secure this
 24 inmate's attendance at the settlement conference scheduled for December 15, 2009 at California
 25 State Prison, Solano, it is necessary that a Writ of Habeas Corpus Ad Testificandum issue
