 21 **IT IS HEREBY STIPULATED** by and between the parties:

22 This case is set for trial on December 8, 2008. Under the Court's scheduling order expert
 23 discovery closes on Friday, September 5, 2008. Plaintiff Susie Abram has identified one expert
 24 witness, Dr. Jeanne Riviore. The City has timely sought to depose Dr. Riviore.

25 The Court heard the City's motion for summary judgment on July 23, 2008. The parties are
 26 awaiting the Court's ruling on that motion. Depending on the outcome of that ruling, the deposition
 27 of Dr. Riviore may be unnecessary. While the parties await that ruling, and in the interest of saving

1 further time and expense, the parties agree to extend the expert discovery cutoff from September 5,
2 2008 to October 10, 2008, and to request that the Court enter an order to that effect. The parties do
3 not anticipate that this will have any adverse impact on their ability to prepare for the November 13,
4 2008 pretrial conference or the December 8, 2008 trial date.
