11	Plaintiff filed the present prose complaint under 42 U.S.C. § 1983 while he was in custody at
12	the Marin County Jail. Plaintiff has since filed a notice of a change of address requesting the Clerk
13	to forward all documents to 1068 Bel Marin Keys Blvd., Novato, California 94949, which the Court
14	assumes is his home address because Plaintiff did not specify that he was transferred to another
15	institution.
16	In an Order dated March 4, 2009, the Court informed Plaintiff that his action could not go
17	forward until he paid the filing fee or filed a completed non-prisoner's in forma pauperis application.
18	The Court ordered the Clerk of the Court to send Plaintiff a blank non-prisoner's in forma pauperis
19	application. The Court informed Plaintiff that he must pay the fee or return the completed
20	application within thirty days or his action would be dismissed.
21	More than thirty days have passed and Plaintiff has not paid the filing fee, returned the non-
22	prisoner's in forma pauperis application or otherwise communicated with the Court.
23	Accordingly, this action is DISMISSED WITHOUT PREJUDICE. The Court has rendered
24	its final decision on this matter; therefore, this Order TERMINATES Plaintiff's case. The Clerk of
25	the Court shall terminate all pending motions and close the file.
26	IT IS SO ORDERED.
