The Court 12 directed Respondent to file an answer to the petition and granted Petitioner leave to file a traverse 13 within thirty days after the answer was filed. In lieu of filing an answer, Respondent has filed a 14 motion to dismiss. Petitioner has not filed an opposition to the motion to dismiss. On October 16, 15 2008, the Court granted Petitioner an extension of time to file an opposition. 16 Before the Court is Petitioner's second request for an extension of time to file an opposition 17 to Respondent's motion to dismiss. 18 Accordingly, the Court GRANTS Petitioner a second extension of time in which to file his 19 opposition to Respondent's motion to dismiss. The time in which Petitioner may file his opposition 20 to Respondent's motion to dismiss will be extended up to and including sixty (60) days from the 21 date of this Order.
