Petitioner, a state prisoner, filed this <u>pro se</u> petition for writ of habeas corpus pursuant to 28 U.S.C. § 2254 and an application for leave to proceed <u>in forma pauperis</u> (IFP). Petitioner has filed a previous petition for a writ of habeas corpus with this Court, challenging the same conviction and sentence. <u>See</u> Case No. C 03-1808 CW (PR). The Court denied the first petition on the merits.

## DISCUSSION

The Court finds the present petition is a second or successive 20 petition attacking the same conviction and sentence as Petitioner's 21 prior federal habeas petition. A second or successive petition 22 containing new claims may not be filed in the district court unless 23 Petitioner first obtains from the United States Court of Appeals an 24 order authorizing the district court to consider the petition. 28 25 U.S.C. § 2244(b)(3)(A). Petitioner has not done so. Accordingly, 26 this petition is DISMISSED without prejudice to filing a new habeas 27 action if Petitioner obtains the necessary order. 28
