1 Plaintiff, BARBARA NEU, on behalf of herself and all others similarly situated
2 ("Plaintiff"), and Defendants, TERMINIX INTERNATIONAL, INC., THE TERMINIX

5 PARTNERSHIP ("Defendants"), hereby agree and stipulate to amending the Court's Case

7 1. On November 25, 2008, this Court amended its August 5, 2008 Case Management
