1 Plaintiffs Western Watersheds Project, *et al.* and Federal Defendant United States Forest Service
2 (the “Parties”) submit this Stipulation and Proposed Order extending the time within which Federal
3 Defendant may respond to Plaintiffs’ Third Amended Complaint. Pursuant to Local Rule 6-2, and in
4 further support of this Stipulation, the Federal Defendant respectfully directs the Court’s attention to the
5 accompanying Declaration of David B. Glazer. The Parties further represent as follows:

6 1. Plaintiffs filed their Third Amended Complaint [Dkt. #103], pursuant to the Parties’
7 Stipulated Agreement and Order [Dkt. #102] ¶ 5, on September 14, 2010. The Federal Defendant’s
8 response to that complaint is due on September 28, 2010.

9 2. Pursuant to the Court’s Minute Order of April 8, 2010 [Dkt. #99], the Federal Defendant
10 filed its renewed Motion To Sever Claims and Transfer Venue [Dkt. #104] on September 22, 2010,
11 which is calendared for hearing on October 27, 2010.

12 3. The Parties stipulate, subject to Court approval, that the Federal Defendant may have up
13 to and including October 22, 2010, to respond to the Third Amended Complaint, which is a date in
14 advance of the hearing on the pending motion to sever and transfer.

15 4. Previous requests for extension of time or continuance are detailed in the Glazer
16 Declaration ¶¶ 2–9.
