12 Before the Court is Plaintiff's request for leave to file an amended complaint.

13 A plaintiff may amend his complaint once as a matter of course at any time before a
14 responsive pleading is served. See Fed. R. Civ. P. 15(a). Where a plaintiff seeks to amend after a
15 responsive pleading has already been served, however, the decision whether to grant leave to amend
16 is committed to the sound discretion of the trial court. Waits v. Weller, 653 F.2d 1288, 1290 (9th
17 Cir. 1981). Federal Rule of Civil Procedure 15(a) is to be applied liberally in favor of amendments
18 and, in general, leave shall be freely given when justice so requires. Janicki Logging Co. v. Mateer,
19 42 F.3d 561, 566 (9th Cir. 1994).

20 The Court notes that the defendants in this action have not been served at this time. Plaintiff
21 may as a matter of course amend his complaint because a responsive pleading has not yet been
22 served. See Fed. R. Civ. P. 15(a). Accordingly, Plaintiff's motion for leave to file an amended
23 complaint is GRANTED.


24 The Clerk of the Court is directed to file Plaintiff's motion, which is labeled "Motion for
