3. If Petitioner wishes to respond to the Answer, he shall do so by filing a Traverse with 2 the Court and serving it on Respondent within sixty (60) days of his receipt of the Answer. Should 3 Petitioner fail to do so, the petition will be deemed submitted and ready for decision sixty (60) days 4 after the date Petitioner is served with Respondent's Answer.

4. Respondent may file a motion to dismiss on procedural grounds in lieu of an Answer, as set forth in the Advisory Committee Notes to Rule 4 of the Rules Governing Section 2254 Cases.
