**STIPULATION AND ORDER
 EXTENDING DEADLINE FOR
 PRODUCTION OF CLASS NOTICE DATA**

1 This Stipulation is entered into by and between Plaintiffs Martin Lewis, Aaron
2 Cooper, and Anissa Schilling (“Plaintiffs”) and Defendant Wells Fargo Bank, N.A. (“Wells
3 Fargo”) (collectively, the “Parties”).

4 **RECITALS**

5 WHEREAS, on October 26, 2009, the Court ordered Wells Fargo to produce to a
6 mutually agreed-upon third-party administrator the names, alternate addresses, email addresses,
7 social security numbers and telephone numbers of all prospective members of the class by
8 November 9, 2009 (Dkt. No. 150 at 9:24);

9 WHEREAS, the parties have agreed on Settlement Services, Inc. (“SSI”) as the
10 third-party administrator; and

11 WHEREAS, the parties have agreed to include the Network Analyst 2 job title and
12 level in the positions to which notice shall be sent, necessitating more time to gather the required
13 data.

14 IT IS HEREBY STIPULATED that the parties propose that the Court extend the
15 deadline for SSI’s receipt of the data to November 13, 2009.
