Petitioner filed an <u>in forma pauperis</u> (hereinafter "IFP") application; however, he did not 12 file copies of the Certificate of Funds and prisoner trust account statement. 13 The Court cannot conduct an initial review of this matter until Petitioner has either paid the 14 filing fee or filed a completed IFP application with the requisite documents. See 28 U.S.C. § 15 1915(a) (a party is permitted to file a civil action in federal court without prepayment of fees or 16 security if he makes an affidavit that he is unable to pay such fees or give security therefor). 17 Accordingly, Petitioner shall pay the requisite \$5.00 filing fee in this action no later than 18 thirty (30) days from the date of this Order. He shall include with his payment a clear indication 19 that it is for the above-referenced case number, C 08-03062 SBA (PR). In the event that Petitioner is 20 unable to pay the filing fee, he shall submit the trust account statement and certificate of funds no 21 later than **thirty** (30) days from the date of this Order.
