 CASE MANAGEMENT CONFERENCE**

Complaint Filed: July 3, 2008

28 On August 22, 2008, the Judicial Panel on Multidistrict Litigation (“JPML”) issued
 Conditional Transfer Order 37 (“CTO-37”) in *In re Ford Motor Company Speed Control*
Deactivation Switch Products Liability Litigation, MDL No. 1718 (“MDL”). CTO-37 conditionally
 transfers the above-entitled action, *Lozano, et al. v. Ford Motor Company*, to the MDL in the
 Eastern District of Michigan and assigns it to the Honorable Bernard A. Friedman. Neither party
 opposes the conditional transfer order and, therefore, the parties expect that the transfer order shall
 become final shortly.
