**ORDER DIRECTING PETITIONER TO
FILE AN AMENDED PETITION**

9 Petitioner, a state prisoner, has filed this petition for a writ of habeas corpus pursuant to 28
10 U.S.C. § 2254.

11 On May 3, 2010, the Court issued an Order granting Petitioner's request for a stay of
12 proceedings while he returned to state court to exhaust his administrative remedies. The Court also
13 stated:

14 Nothing further will take place in this action until Petitioner receives a final decision
15 from the California Supreme Court and, within **thirty (30) days** of doing so, moves to
16 reopen the action, lift the Court's stay and amend the stayed petition to add the
newly-exhausted claims.

17 (May 3, 2010 Order at 3.)

18 On January 24, 2011, Petitioner informed the Court that his state proceedings had concluded;
19 however, he did not amend the stayed petition to add the newly-exhausted claims. Therefore,
20 Petitioner must file an amended petition in this Court which incorporates the newly-exhausted
21 claims he intends to raise in federal court, as directed below.

22 **CONCLUSION**


23 1. No later than **thirty (30) days** of the date of this Order, Petitioner must file an
24 amended petition in this Court which incorporates the newly-exhausted claims he intends to raise in
25 federal court. The Court will lift the stay on the date that Petitioner files his amended petition.
26 Petitioner must submit the amended petition on the attached blank habeas petition form, clearly label
27 the petition as the "Amended Petition," and write in the case number for this action on the form. He
28 should also attach to his amended petition a copy of his petition to the California Supreme Court, if

1 the document is available to him. **If Petitioner fails to file an amended petition within the**
2 **prescribed period, the Court will dismiss this action without prejudice for failure to prosecute.**

3 2. The Clerk of the Court shall send Petitioner a blank § 2254 habeas petition form.

4 IT IS SO ORDERED.
