General Agents Insurance Company of America, Inc.;

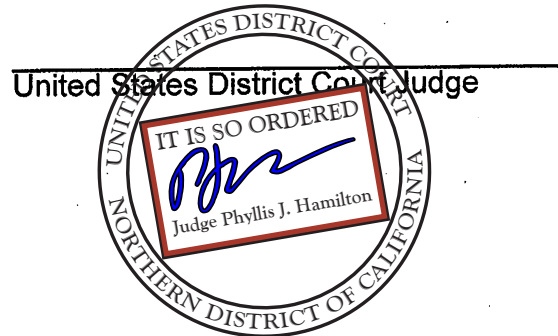
Whereas, in the interests of conserving judicial resources and the


