STIPULATED PERMANENT INJUNCTION

22 WHEREAS, Plaintiff Packaging Aids Corporation filed the instant action against
23 Liston Bevard, individually and doing business as Impulse Dynamics, and Impulse
24 Dynamics, a Nevada Corporation, on September 3, 2008; and

25 WHEREAS, defendants were served with the complaint on January 25, 2009; and

26 WHEREAS, defendants have had an opportunity to seek counsel, and have chosen

1 not to do so; and

2 WHEREAS, the parties have reached an agreement to resolve the outstanding
3 issues between them;

4 THE PARTIES HEREBY STIPULATE AS FOLLOWS:

5 1. Plaintiff owns the "Vertrod" trademark and the stylized "V" mark.

6 2. Defendants will remove from the www.impulsedynamics.com website any
7 and all usages of the "Vertrod" trademark and the stylized "V" mark, including use as
8 metatags. Defendants may use the term "Vertrod" in a non-trademark capacity, such as
9 "compatible with Vertrod brand machines."

10 3. Defendants will alter the www.impulsedynamics.com website to remove all
11 claims that could be construed as suggesting it is connected with Vertrod in any way,
12 including specifically, any claim of being the "source authority."

13 4. The www.impulsedynamics.com website, as well as any other website or
14 advertising in the possession, custody, or control of Defendants, their agents, or anyone
15 acting in concert with Defendants, will have a prominent disclaimer on any page that
16 mentions Vertrod, in any way, that the website or other item is "not connected in any way
17 to Vertrod, which is the trademark of Packaging Aids Corporation." The disclaimer will
18 be in a font and typesize at least as large as the most common font and typesize used on
19 the page, and placed in a box designed to be seen by an average website visitor without
20 having to scroll from the top of the page.

21 5. Defendants will relinquish control to Plaintiff of any and all websites in
22 their possession, custody or control incorporating the term "vertrod" in its name,
23 including but not limited to www.vertrod.net and www.vertrod.org. Defendants, their
24 agents or successors, or those acting in concert with Defendants, will not maintain any
25 website with the term "vertrod" in its name.

26 IT IS SO STIPULATED.




