**STIPULATION AND [~~PROPOSED~~] ORDER  
 EXTENDING TIME TO CONDUCT EXPERT  
 DISCOVERY**

20 WHEREAS the Court’s current deadline for the last day to make expert disclosures  
 21 is June 10, 2011; and

22 WHEREAS the Court’s current cut-off for expert discovery is August 12, 2011;  
 23 and

24 WHEREAS the parties currently have pending motions for summary judgment, or  
 25 partial summary judgment scheduled for hearing on June 29, 2011; and

26 WHEREAS the Court’s rulings on the parties’ pending motions for summary  
 27 judgment or partial summary judgment will likely affect the issues that will ultimately be  
 28 tried in the case; and

1 WHEREAS there is currently no trial date set in these two actions by the Court;  
2 IT IS HEREBY STIPULATED BY THE PARTIES, subject to the approval of the  
3 Court, that the deadline for conducting expert disclosures is extended to 30 days after the  
4 Court issues a ruling on the parties' pending motions for summary judgment, or partial  
5 summary judgment, and

6 IT IS FURTHER STIPULATED BY THE PARTIES, subject to the approval of  
7 the Court, that the expert discovery cut-off is extended to 90 days from the date after the  
8 Court issues a ruling on the parties' pending motions for summary judgment, or partial  
9 summary judgment.

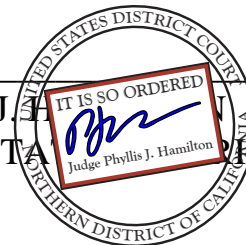
