1 WHEREAS, on May 4, 2010, Plaintiff filed its motion for (1) default judgment awarding
2 damages against Defendants Kevin Mesiab d/b/a/ Ezadsuite.com and EasyAd LLC, and
3 (2) motion to amend judgment to add Mesiab Labs LLC as a judgment debtor,

4 WHEREAS, on May 27, 2010, Plaintiff filed a supplemental declaration regarding
5 attorneys' fees and costs,

6 WHEREAS, on June 23, 2010, Defendants requested and on June 24, 2010, the Court
7 granted Defendants' request to continue the hearing on the motion for (1) default judgment
8 awarding damages against Defendants Kevin Mesiab d/b/a/ Ezadsuite.com and EasyAd LLC, and
9 (2) motion to amend judgment to add Mesiab Labs LLC as a judgment debtor,

10 WHEREAS, on July 1, 2010, Defendants filed their response to Plaintiff's motion for

3 judgment to add Mesiab Labs LLC as a judgment debtor is continued to August 12, 2010 at 10:00
4 a.m. in Courtroom B, 15th Floor, 450 Golden Gate Avenue, San Francisco, California.
