1 Pursuant to Civil L.R. 7-11, Plaintiff FlipChip International, LLC brought a Miscellaneous
2 Administrative Request To Continue Case Management Conference And Associated Deadlines By 60
3 Days To Allow Parties to Continue Settlement Discussions. Having considered the request and
4 finding good cause therefore, the Court has GRANTED the request.

5 It is therefore Hereby ORDERED that:

6 1. The Court's November 18, 2008 Order Setting Initial Case Management Conference
7 and ADR Deadlines, which required the filing of a Joint Case Management Conference Statement by
8 February 17, 2009 and set an Initial Case Management Conference for February 24, 2009, at 4:00
9 p.m. in Oakland Courtroom 4, is vacated;

10 2. The Case Management Conference and all associated deadlines are continued for 60
11 days;

12 3. At the Court's convenience, the Case Management Conference shall be rescheduled
13 for ~~a date on or after~~ April 27, 2009, at 4:00 p.m., with the Joint Case Management Conference
14 Statement due seven court days prior to the conference date.
