20 In accordance with the provisions of Federal Rule of Civil Procedure 41(a)(1)(A)(ii),
 21 Plaintiffs, by and through their attorney of record, Robert Jobe, and Defendants, by and through their
 22 attorney of record, Sherease Pratt, hereby stipulate to dismissal of the above-entitled action without
 23 prejudice, in light of the fact that the Government has agreed to (1) move the immigration court to
 24 dismiss the Plaintiffs' immigration court proceedings, without prejudice; (2) reopen and
 25 recommence asylum termination proceedings through the issuance of a new Notice of Intent to
 26 Terminate, if and when the Immigration Judge grants the Government's motion to dismiss the
 27 immigration court proceedings without prejudice; and 3) by operation of law, once termination
 28 proceedings are reopened, Plaintiffs will revert to their previous immigration status until such status
