**STIPULATION TO CONTINUE CASE
MANAGEMENT CONFERENCE; AND
ORDER**

21 The parties to this action, by and through undersigned counsel, hereby stipulate, subject to
22 the approval of the Court, as follows:

23 1. Plaintiffs filed this action on January 7, 2009. The United States Attorney's Office
24 was not served until March 10, 2009. Accordingly, Defendants' answer or other response to the
25 Complaint is currently due on May 11, 2009. See Fed. R. Civ. P. 12(a)(2).

26 2. Pursuant to this Court's January 7, 2009, Order Setting Initial Case Management
27 Conference and ADR Deadlines, the parties are required to file a joint case management statement
28 on April 7, 2009, and to attend a case management conference on April 14, 2009.

1 3. In order to allow sufficient time for Defendants to review the allegations in the
2 Complaint, and for the parties to confer to determine whether ADR would be beneficial and to
3 prepare a joint case management statement, the parties — without waiving any rights under Rule
4 26 or the Court's Order Setting Initial Case Management Conference and ADR Deadlines — hereby
5 respectfully request that the Court extend the dates in its Scheduling Order as follows:

6 Last day to complete meet and confer conference pursuant to Rule 26(f):	April 30, 2009
7 Last day to file ADR Certification:	May 26, 2009
8 Last day to file Rule 26(f) Report:	June 9, 2009
9 Initial Case Management Conference:	June 16, 2009, at 2:00 p.m.


