1 **SUBJECT TO THE APPROVAL OF THIS COURT, THE PARTIES, THROUGH**
2 **THEIR RESPECTIVE ATTORNEYS OF RECORD, HEREBY STIPULATE TO**
3 **THE FOLLOWING PROPOSED ORDER WITH REFERENCE TO THE**
4 **FOLLOWING FACTS:**

5 WHEREAS, Plaintiffs initiated a civil lawsuit in the Northern District Court of
6 California, before the Honorable Phyllis J. Hamilton, against Defendants;

7 WHEREAS, Defendants filed a Motion to Dismiss Plaintiffs' Complaint;

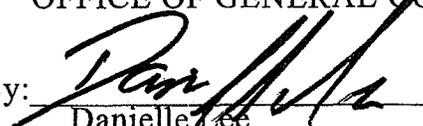
