The parties hereby submit this Joint Request To Reschedule Case Management Conference For 30 Days After Mediation And Other Pretrial Deadlines. In accordance with the Court's Scheduling Order, representatives of WiMAX Forum ("Plaintiff") and defendants Yankee Group Research, Inc., Weinman Corporation, and Eliot Weinman ("Defendants") are scheduled to mediate their claims with Anthony M. Keats, Esq. of Keats McFarland & Wilson LLP. The mediation will occur on September 29, 2009 in San Francisco, California.

Defendants have informed Plaintiff that if the parties are unable to resolve this dispute at mediation, defendants Eliot Weinman and Weinman Corporation intend to seek dismissal of the action against them for lack of personal jurisdiction.
