It is well settled that the Court need not consider motions filed pro se where the **16** party is represented by counsel. E.g., United States. v. El-Alamin, 574 F.3d 915, 923 (8th Cir. 2009); Ennis v. LeFevre, 560 F.2d 1072 (2d Cir. 1977). In addition, it is improper to file a **17** 18 motion for reconsideration without first obtaining leave of Court to do so. Civ. L.R. 7-9. 19 Accordingly, 20 IT IS HEREBY ORDERED THAT Plaintiff's pro se motion for reconsideration is 21 DENIED without prejudice.
