UNOPPOSED REQUEST BY INSURER
 FOR PERMISSION TO APPEAR
 BY PHONE AT DECEMBER 13,
 2011 SETTLEMENT CONFERENCE

21 AND RELATED COUNTERCLAIMS AND
 22 THIRD PARTY CLAIMS

1 Further to Magistrate Judge Zimmerman’s Settlement Conference Order dated
2 November 21, 2011 (Dkt. No. 293), Emerging Markets Communications, Inc. and EMC
3 Satcom Technologies, Inc. (collectively “EMC”) hereby submit this Request for its
4 insurance carrier representative, Sandra Walker, to be granted permission to attend the
5 December 13, 2011 Settlement Conference in front of Judge Zimmerman by telephone.
6 In support hereof, EMC states as follows:

7 Ms. Walker is the carrier representative with responsibility for litigation matters
8 related to EMC’s relevant insurance policy, and any other representative of the carrier
9 would need Ms. Walker’s permission before providing carrier approval to settlement
10 terms. Ms. Walker is unable to travel to San Francisco for the December 13, 2011
11 settlement conference due to her responsibilities for the care of others that week. First,
12 Ms. Walker has power of attorney for a veteran who is undergoing surgery on December
13 12 and who has no relatives to speak on her behalf. Furthermore, Ms. Walker’s mother is
14 due to be released from post-stroke rehabilitation around December 13, and Ms. Walker
15 needs to be available to assist with that process. Also, Ms. Walker’s father sought
16 treatment for a possible stroke on November 22, 2011, and Ms. Walker anticipates that
17 she will need to assist in providing care for him over the coming weeks.

18 Ms. Walker will be available via cellular telephone, with the number provided to
19 EMC’s counsel, throughout the day on December 13, 2011, should carrier consent to any
20 proposed settlement terms be required.

21 For the foregoing reasons, EMC respectfully requests that the Court allow its
22 insurance carrier representative, Sandra Walker, to appear for the December 13, 2011
23 Settlement Conference via telephone.
