INTRODUCTION

Plaintiff, who is currently incarcerated at Santa Rita Jail, has filed a pro se civil rights action pursuant to 42 U.S.C. § 1983 alleging that Defendants used excessive force against him and were deliberately indifferent to his serious medical needs.

His motion for leave to proceed in forma pauperis has been granted.

Venue is proper because the events giving rise to the claim are alleged to have occurred at the Santa Rita Jail, which is located in this judicial district. See 28 U.S.C. § 1391(b).

In his complaint, Plaintiff names the following Defendants: Alameda County Deputies J. Cooper, Z. L. Griffith and G. Mora. Plaintiff seeks monetary damages.

DISCUSSION

I. Standard of Review

A federal court must conduct a preliminary screening in any case in which a prisoner seeks redress from a governmental entity or officer or employee of a governmental entity. 28 U.S.C. § 1915A(a). In its review, the court must identify any cognizable claims and dismiss any claims that are frivolous, malicious, fail to state a claim upon which relief may be granted or seek monetary relief from a defendant who is immune from such relief. Id. § 1915A(b)(1), (2). Pro se pleadings must be liberally construed. Balistreri v. Pacifica Police Dept., 901 F.2d 696, 699 (9th Cir. 1988).

To state a claim under 42 U.S.C. § 1983, a plaintiff must allege two essential elements:

(1) that a right secured by the Constitution or laws of the United States was violated, and

1 (2) that the alleged violation was committed by a person acting under the color of state law. West v.
2 Atkins, 487 U.S. 42, 48 (1988).

3 **II. Legal Claims**

4 **A. Excessive Force**

5 A prisoner has the right to be free from cruel and unusual punishment, including physical
6 abuse by guards. Whenever prison officials stand accused of using excessive physical force in
7 violation of the Eighth Amendment, the core judicial inquiry is whether force was applied in a good-
8 faith effort to maintain or restore discipline, or maliciously and sadistically to cause harm. Hudson
9 v. McMillian, 503 U.S. 1, 6 (1992) (citing Whitley v. Albers, 475 U.S. 312, 317 (1986)).

10 Plaintiff alleges that while he was serving "9 month on bogus charges," he was subjected to
11 excessive force by Defendants Cooper, Griffith and Mora in 2005.¹ Specifically, Plaintiff alleges
12 that Defendant Cooper "instigated a conflict in which he [was taken] advantage of" (Compl. at
13 3.) Defendant Cooper "ordered [Plaintiff] out of [his] cell 3-4 hours post an argument." (Id.) When
14 Plaintiff "emerged" from his cell, he saw the "majority of the deputy's [sic] on that watch lying in
15 wait in full combat uniform." (Id.) Plaintiff claims that Defendant Cooper "asked [him] to cuff up
16 when [he] obliged [Defendant Cooper] yelled stop resisting and it was mayhem after that all [he]
17 remember[s] is waking up in a cell, then a brief medical escort to the nurse." (Id.) Plaintiff alleges
18 that he was "heckled into another verbal dispute in cuffs still and [Defendants] took the liberty to
19 assault [him] again . . . with weapons and unnecessary [sic] violence on the trip to ad-seg with Z. L.
20 Griffith and G. Mora in which [he] was beat relentlessly." (Id.) Plaintiff claims he was "charged
21 w/battery before they dropped [the] case." (Id.)

22 Liberally construed, Plaintiff's complaint states a cognizable Eighth Amendment claim
23 against Defendants Cooper, Griffith and Mora.

24 **B. Deliberate Indifference Claim**

25 Plaintiff's allegations also state a claim for deliberate indifference to his serious medical

27 ¹ Plaintiff does not state the exact date of the incident; however, he indicates that he filed an
28 "excessive force grievance," number "04G-S1095," on or around August 19, 2005. (Compl. at 2.)
Therefore, the Court assumes that the incident took place in 2005, and that Defendants can discover
the exact date by referring to the aforementioned grievance.

1 needs.

2 Deliberate indifference to serious medical needs violates the Eighth Amendment's
3 proscription against cruel and unusual punishment. See Estelle v. Gamble, 429 U.S. 97, 104 (1976);
4 McGuckin v. Smith, 974 F.2d 1050, 1059 (9th Cir. 1992), overruled on other grounds, WMX
5 Technologies, Inc. v. Miller, 104 F.3d 1133, 1136 (9th Cir. 1997) (en banc); Jones v. Johnson, 781
6 F.2d 769, 771 (9th Cir. 1986). A determination of "deliberate indifference" involves an examination
7 of two elements: the seriousness of the prisoner's medical need and the nature of the defendant's
8 response to that need. See McGuckin, 974 F.2d at 1059. A "serious" medical need exists if the
9 failure to treat a prisoner's condition could result in further significant injury or the "unnecessary
10 and wanton infliction of pain." Id. (citing Estelle v. Gamble, 429 U.S. at 104). A prison official is
11 deliberately indifferent if he or she knows that a prisoner faces a substantial risk of serious harm and
12 disregards that risk by failing to take reasonable steps to abate it. Farmer v. Brennan, 511 U.S. 825,
13 837 (1994).

14 Plaintiff states that he was not given medical treatment "after [the] second assault." (Compl.
15 at 4.) Liberally construed, Plaintiff's complaint states a cognizable claim against Defendants
16 Cooper, Griffith and Mora for deliberate indifference to his medical needs.

17 CONCLUSION

18 For the foregoing reasons, the Court orders as follows:

19 1. Plaintiff states cognizable Eighth Amendment claims for the use of excessive force
20 and for deliberate indifference to serious medical needs against Defendants Cooper, Griffith and
21 Mora.

22 2. The Clerk of the Court shall mail a Notice of Lawsuit and Request for Waiver of
23 Service of Summons, two copies of the Waiver of Service of Summons, a copy of the complaint and
24 all attachments thereto (docket no. 1) and a copy of this Order to **Alameda County Deputies J.**
25 **Cooper, Z. L. Griffith and G. Mora**. The Clerk of the Court shall also mail a copy of the
26 complaint and a copy of this Order to the Alameda County Counsel's Office. Additionally, the
27 Clerk shall mail a copy of this Order to Plaintiff.

28 3. Defendants are cautioned that Rule 4 of the Federal Rules of Civil Procedure requires

1 them to cooperate in saving unnecessary costs of service of the summons and complaint. Pursuant
2 to Rule 4, if Defendants, after being notified of this action and asked by the Court, on behalf of
3 Plaintiff, to waive service of the summons, fail to do so, they will be required to bear the cost of
4 such service unless good cause be shown for their failure to sign and return the waiver form. If
5 service is waived, this action will proceed as if Defendants had been served on the date that the
6 waiver is filed, except that pursuant to Rule 12(a)(1)(B), Defendants will not be required to serve
7 and file an answer before **sixty (60) days** from the date on which the request for waiver was sent.
8 (This allows a longer time to respond than would be required if formal service of summons is
9 necessary.) Defendants are asked to read the statement set forth at the foot of the waiver form that
10 more completely describes the duties of the parties with regard to waiver of service of the summons.
11 If service is waived after the date provided in the Notice but before Defendants have been
12 personally served, the Answer shall be due **sixty (60) days** from the date on which the request for
13 waiver was sent or **twenty (20) days** from the date the waiver form is filed, whichever is later.

14 4. Defendants shall answer the complaint in accordance with the Federal Rules of Civil
15 Procedure. The following briefing schedule shall govern dispositive motions in this action:

16 a. No later than **ninety (90) days** from the date their answer is due, Defendants
17 shall file a motion for summary judgment or other dispositive motion. The motion shall be
18 supported by adequate factual documentation and shall conform in all respects to Federal Rule of
19 Civil Procedure 56. If Defendants are of the opinion that this case cannot be resolved by summary
20 judgment, they shall so inform the Court prior to the date the summary judgment motion is due. All
21 papers filed with the Court shall be promptly served on Plaintiff.

22 b. Plaintiff's opposition to the dispositive motion shall be filed with the Court
23 and served on Defendants no later than **sixty (60) days** after the date on which Defendants' motion
24 is filed. The Ninth Circuit has held that the following notice should be given to pro se plaintiffs
25 facing a summary judgment motion:

26 The defendant has made a motion for summary judgment by which they seek
27 to have your case dismissed. A motion for summary judgment under Rule 56 of the
Federal Rules of Civil Procedure will, if granted, end your case.

28 Rule 56 tells you what you must do in order to oppose a motion for summary

1 judgment. Generally, summary judgment must be granted when there is no genuine
2 issue of material fact -- that is, if there is no real dispute about any fact that would
3 affect the result of your case, the party who asked for summary judgment is entitled
4 to judgment as a matter of law, which will end your case. When a party you are
5 suing makes a motion for summary judgment that is properly supported by
6 declarations (or other sworn testimony), you cannot simply rely on what your
7 complaint says. Instead, you must set out specific facts in declarations, depositions,
8 answers to interrogatories, or authenticated documents, as provided in Rule 56(e),
9 that contradict the facts shown in the defendant's declarations and documents and
10 show that there is a genuine issue of material fact for trial. If you do not submit your
11 own evidence in opposition, summary judgment, if appropriate, may be entered
12 against you. If summary judgment is granted [in favor of the defendants], your case
13 will be dismissed and there will be no trial.

14 See Rand v. Rowland, 154 F.3d 952, 962-63 (9th Cir. 1998) (en banc).

15 Plaintiff is advised to read Rule 56 of the Federal Rules of Civil Procedure and Celotex
16 Corp. v. Catrett, 477 U.S. 317 (1986) (party opposing summary judgment must come forward with
17 evidence showing triable issues of material fact on every essential element of his claim). Plaintiff is
18 cautioned that because he bears the burden of proving his allegations in this case, he must be
19 prepared to produce evidence in support of those allegations when he files his opposition to
20 Defendants' dispositive motion. Such evidence may include sworn declarations from himself and
21 other witnesses to the incident, and copies of documents authenticated by sworn declaration.
22 Plaintiff will not be able to avoid summary judgment simply by repeating the allegations of his
23 complaint.

24 c. If Defendants wish to file a reply brief, they shall do so no later than **thirty**
25 **(30) days** after the date Plaintiff's opposition is filed.

26 d. The motion shall be deemed submitted as of the date the reply brief is due.
27 No hearing will be held on the motion unless the Court so orders at a later date.

28 5. Discovery may be taken in this action in accordance with the Federal Rules of Civil
Procedure. Leave of the Court pursuant to Rule 30(a)(2) is hereby granted to Defendants to depose
Plaintiff and any other necessary witnesses confined in prison.

6. All communications by Plaintiff with the Court must be served on Defendants, or
Defendants' counsel once counsel has been designated, by mailing a true copy of the document to
Defendants or Defendants' counsel.

7. It is Plaintiff's responsibility to prosecute this case. Plaintiff must keep the Court

1 informed of any change of address and must comply with the Court's orders in a timely fashion.


2 8. Extensions of time are not favored, though reasonable extensions will be granted.

3 Any motion for an extension of time must be filed no later than **fifteen (15) days** prior to the

4 deadline sought to be extended.

5 IT IS SO ORDERED.
