2 consolidated cases of *Douglas (formerly Maxwell-Jolly) v. Independent Living Center of Southern*
3 *California*, U.S. Supreme Court Case No. 09-958, *Douglas v. California Pharmacists Ass'n*, U.S.
4 Supreme Court Case No. 09-1158; and *Douglas v Santa Rosa Memorial Hospital*, U.S. Supreme Court
5 Case No. 10-283; and

6 WHEREAS, this Court previously signed a stipulation and order staying the case pending
7 disposition of *Douglas v. California Pharmacists Ass'n*, U.S. Supreme Court Case No. 09-1158, except
8 that the Court can lift this stay at any time and any party can lift this stay upon three (3) calendar days'
9 prior written notice to the Court and all other parties; and


