The case was assigned to Magistrate Judge Bernard 13 Zimmerman, who dismissed the complaint with leave to amend, pursuant to 28 U.S.C. 14 § 1915(e)(2)(B). Plaintiff failed to file an amended complaint by the July 31, 2009 deadline nor 15 did she seek an extension of time to do so. On August 18, 2009, Magistrate Judge Zimmerman 16 issued a Recommendation of Dismissal (Docket 5) in which he recommended dismissing the action 17 on the ground that Plaintiff failed to amend her complaint as ordered. He ordered the case 18 reassigned to a district judge to review his recommendation. Upon reassignment, this Court has 19 reviewed the file and concurs in the recommendation. Accordingly, the Court hereby adopts the 20 Recommendation of Dismissal and DISMISSES the action without further leave to amend.
