ORDER DIRECTING PLAINTIFF TO SHOW CONTINUED INTENT TO PROSECUTE THIS ACTION

D. MILLER, et al.,

Plaintiff filed the instant pro se civil rights complaint under 42 U.S.C. § 1983 in the United States District Court for the Eastern District of California, and in an Order dated June 9, 2009, Magistrate Judge Gregory G. Hollows of the Eastern District transferred this action to this Court.¹ On June 12, 2009, the Clerk of the Court informed Plaintiff that this case had been transferred to the Northern District.

Pursuant to Federal Rule of Civil Procedure 41(b), a district court may sua sponte dismiss an action for failure to prosecute or to comply with a court order. See Link v. Wabash R.R., 370 U.S. 626, 633 (1962); McKeever v. Block, 932 F.2d 795, 797 (9th Cir. 1991). But such a dismissal should only be ordered when the failure to comply is unreasonable. See id. A district court should afford the litigant prior notice of its intention to dismiss. See Malone v. United States Postal Serv., 833 F.2d 128, 133 (9th Cir. 1987).

In the instant case, Plaintiff has failed to communicate with the Court since this case has been transferred to the Northern District. Furthermore, the June 12, 2009 notice was returned as undeliverable on June 24, 2009 with a notation: "Return to Sender -- Inmate Refused." Accordingly, it is in the interests of justice and judicial efficiency for the Court to establish whether

¹ Magistrate Judge Hollows indicated that he was construing Plaintiff's action as a civil rights action, stating: "Because petitioner is challenging the conditions of his confinement, the court construes this action as a civil rights action pursuant to 42 U.S.C. § 1983. (June 9, 2009 Order at 1 (citing Ramirez v. Galaza, 334 F.3d 850 (9th Cir. 2003).)

Plaintiff intends to continue to prosecute this action. Plaintiff shall file a notice of his continued intent to prosecute no later than **thirty (30) days** of the date of this Order. Failure to do so will result in the dismissal of this action without prejudice for failure to prosecute under Rule 41(b) of the Federal Rules of Civil Procedure. See Malone, 833 F.2d at 133 (the district court should afford the litigant prior notice before dismissing for failure to prosecute).
