 20 **STIPULATION FOR JOINDER OF ERISA**
 21 **PLANS AND DISMISSAL OF UNUM**
 22 **[PROPOSED] ORDER**

23 This Stipulation is entered into by and among Plaintiff, Jeff Renfro ("Plaintiff"), and
 24 Defendant, Unum Life Insurance Company Of America ("Unum"), through their respective
 25 attorneys of record herein, as follows:

- 26 (1) The two ERISA plans at issue in Plaintiff's Complaint – "The Funky Door Long
 27 Term Disability Plan" and "The ServiceMaster Long Term Disability Plan" – are hereby joined as
 28 defendants in this action (hereinafter "The Plans").
- 29 (2) Upon the joinder of The Plans as defendants in this action, Plaintiff agrees that Unum
 30 will be dismissed from the action with prejudice in exchange for a waiver of costs by Unum. Unum
 31 agrees to honor its obligations under the insurance policies that fund The Plans.
- 32 (3) Unum's current counsel, Rimac & Martin, is to remain as counsel and represent The
 33 Plans in this action.

1 (4) No Amended Complaint or Answer will be required to effectuate the joinder of The
2 Plans and the dismissal of Unum; The Plans will simply be substituted into the existing Complaint in
3 place and instead of Unum.

4 (5) The current briefing schedule will remain in effect, and the current hearing date of
5 June 8, 2010, will remain on calendar.


