 19 Good cause having been shown by the Petitioner upon its Petition and Memorandum in Support

21 **ORDERED** that respondent, Ni Chi Nguyen, is ordered to appear before this Court on March 9,

 24 compelled to appear at the removal hearing of Luu Thi Pham (A57-960-802) in Immigration Court

26 **ORDERED** that a copy of this Order to Show Cause, together with a copy of the Petition to  
 27 Enforce a Subpoena, as well as the petitioner’s Memorandum in Support of Petition, the  
 28 Declaration of Edward A. Olsen, and petitioner’s Request for Issuance of an Order to Show Cause,

1 be served upon respondent at least thirty-five (35) days before the return date of this Order to Show  
2 Cause above specified;

3 **ORDERED** that no later than twenty-one (21) days before the return date of this Order, the  
4 respondent may file and serve a written response to the Petition to Enforce A Subpoena, as well as  
5 the petitioner's Memorandum In Support of Petition, the Declaration of Edward A. Olsen, and  
6 petitioner's Request for Issuance of an Order to Show Cause, supported by appropriate affidavit(s)  
7 or declaration(s) in conformance with 28 U.S.C. § 1746; and that is further

8 **ORDERED** that the petitioner may file and serve a written reply to such response, if any,  
9 within fourteen (14) days before the return date of this Order.
