1 THIS MATTER came before the Court for hearing on December 15, 2010 on plaintiff's
2 Motion for Leave to file a Supplemental and Amended Complaint and to Remand the Action to
3 State Court (Doc. No. 291). At the hearing, the Court granted JSR's motion for leave to file its
4 Supplemental and Amended Complaint, and JSR has now filed that pleading. The Supplemental
5 and Amended Complaint adds Marsh & McLennan Companies, Inc. ("Marsh") as a defendant in
6 the action. Both plaintiff JSR Micro, Inc. and Marsh are incorporated in Delaware. Because the
7 Court's sole basis for subject matter jurisdiction over this action is diversity jurisdiction, and there
8 is no longer complete diversity between plaintiff and all defendants, the Court no longer has
9 subject matter jurisdiction over this action. Accordingly, this action is hereby remanded to the
10 Superior Court for the City and County of San Francisco, and the Clerk is hereby directed to
11 execute such remand.
