 12 Respondent has filed an answer. Petitioner now moves for an extension of time to file a traverse.
 13 Good cause appearing, the request is GRANTED. Petitioner shall file a traverse by **thirty (30) days**
 14 from the date of this Order.

15 Petitioner also moves for "the Court to order Respondent to serve Petitioner [with] the
 16 Answer" (Pet'r Mot. at 1.) The Court construes Petitioner's motion as a request for an Order
 17 directing Respondent to serve Petitioner with the answer and any attached exhibits. Good cause
 18 appearing, the request is GRANTED. Respondent shall serve Petitioner with a copy of the answer
 19 and any attached exhibits, which the Court assumes were previously lodged with the answer, on or
 20 before **three (3) days** from the date of this Order.
