I have received the official ruling from Texas on the status of Vince's amateurism issues. The compliance director, Amy Folan, told me that Vince is free to go commercial with his image because he sent the Athletic Dept a letter confirming his intentions to declare for the NFL Draft. From what Amy told me, it doesn't sound like they have a contact in Vince's family or an agent to send requests to yet, but they are expecting to get one at some point. They have just been keeping a running list of all requests and known products to eventually share with Vince's representatives.

Chris Plonsky suggested that you try to contact Coach Brown to get this dialogue started. They have not been able to focus on it this week because of celebration planning. Casey Johnson is his administrative assistant and her number is 512.471.4979.

Derek outlined some of the key deal points we may want to put into a one-page proposal if we think this is going to go anywhere after your initial conversation with Coach Brown. You may also want to let him know we've heard rumors that he is signing with Bus Cook and our staff has a relationship with him.

CLC's Background

Why It Makes Sense (UT's agent, prior track record with Manning, speed to market, enforcement synergies, our staff is getting questions from licensees)

Categories to be Represented: Prints, Posters, Publishing, Apparel, Autographed Memorabilia,

Other: We will design an official VY/UT logo to serve as the authenticating mark for official VY merchandise; maybe can even develop a VY hangtag for all VY merchandise if JP can do one quickly enough

Royalty Rate: 12% NC rate to Texas, 3% to Rose Bowl, 5% to VY; or 8% to VY and 8% to UT on any non-national champions products; or 16% to VY on VY-only products

Fee Structure: 25% to CLC; 75% to VY or his assigned agency (the Manning deal was 80%/20% and gave us the rights to use Manning's name in conjunction with Tennessee marks)

Term: Term of two years for all products featuring UT or RB logos; term of 1/10/06 - the NFL draft for VY's individual likeness rights (so he can still go sign his trading card deals, top draft pick deals, shoe deals, etc. around CLC).

Approval Rights: VY and family will have full approval rights over all deals
