In its Order of October 27, 2009, the Court noted that its 19 records did not show that Plaintiff had served WMC Mortgage Corp., 20 Litton Loan Servicing, California Combo Mortgage, DMW Realty and 21 Enrique Alvarez within 120 days of filing her original complaint as 22 required by Federal Rule of Civil Procedure 4(m). (Docket No. 11.) 23 The Court thereby ordered Plaintiff to serve her amended complaint 24 on all Defendants within ten days of filing it and warned that her 25 failure to comply with the order would result in dismissal with 26 prejudice.

27 Plaintiff filed her amended complaint on November 16, 2009.
28 The ten-day period for Plaintiff to serve the abovementioned

United States District Court For the Northern District of California Defendants has passed and there are no proofs of service before the
 Court to show that these Defendants were properly served.
 Accordingly, the Court dismisses with prejudice Plaintiff's claims
 against WMC Mortgage Corp., Litton Loan Servicing, California Combo
 Mortgage, DMW Realty and Enrique Alvarez.

Defendants JP Morgan Chase Bank, N.A. and Chase Home Finance 6 7 LLP (collectively, Chase) have filed a motion to dismiss 8 Plaintiff's amended complaint. Defendant Resurgent Capital 9 Services has joined in Chase's motion. As noted in the Clerk's Notice of December 4, 2009, Plaintiff's opposition to this motion 10 will be due December 17, 2009, and any reply will be due December 11 12 24, 2009. This motion will be taken under submission on the 13 papers.
