12 On October 12, 2010, the Court warned Plaintiff Reena Chopra
13 that, if she did not oppose Defendants' motions to dismiss by
14 October 19, 2010, her case would be dismissed for failure to
15 prosecute. On October 19, Plaintiff responded that she had not
16 received Defendants' motions,¹ which she eventually obtained from
17 the Clerk of the Court, and requested additional time to oppose
18 them. The Court granted Plaintiff's request, directed her to
19 oppose Defendants' motions by November 9, 2010 and warned her that,
20 if she did not do so, her action would be dismissed for failure to
21 prosecute.

22 Notwithstanding the Court's first warning, subsequent
23 extension of time and second warning, Plaintiff failed to file any
24 opposition to Defendants' motions. Accordingly, Plaintiff's action
25 is dismissed without prejudice for failure to prosecute.

27 ¹ Notably, Defendants' motions were accompanied by proofs of
28 service, indicating that Plaintiff was served through United States
Mail at the address listed in the Court's records. Plaintiff has
received Court orders sent to this address.

1 Defendants' motions to dismiss are DENIED as moot (Docket Nos. 45,
2 49 and 51). The Clerk shall close the file.
