ORDER DISMISSING PLAINTIFF'S ACTION FOR FAILURE TO PROSECUTE AND DENYING AS MOOT DEFENDANTS' MOTIONS TO DISMISS (Docket Nos. 45, 49 and 51)

On October 12, 2010, the Court warned Plaintiff Reena Chopra that, if she did not oppose Defendants' motions to dismiss by October 19, 2010, her case would be dismissed for failure to prosecute. On October 19, Plaintiff responded that she had not received Defendants' motions, which she eventually obtained from the Clerk of the Court, and requested additional time to oppose them. The Court granted Plaintiff's request, directed her to oppose Defendants' motions by November 9, 2010 and warned her that, if she did not do so, her action would be dismissed for failure to prosecute.

Notwithstanding the Court's first warning, subsequent extension of time and second warning, Plaintiff failed to file any opposition to Defendants' motions. Accordingly, Plaintiff's action is dismissed without prejudice for failure to prosecute.

Notably, Defendants' motions were accompanied by proofs of service, indicating that Plaintiff was served through United States Mail at the address listed in the Court's records. Plaintiff has received Court orders sent to this address.
