1 WHEREAS, on January 4, 2013, plaintiffs filed Plaintiffs' Notice of Motion and Motion
2 for Leave to Amend to File a Fourth Consolidated Amended Complaint for Violations of the
3 Federal Securities Laws (the "Motion") (Docket No. 128) in the above-captioned matter;

4 WHEREAS, on January 11, 2013, the Court entered a briefing schedule (Docket No.
5 132) that set the deadline for Oppositions to the Motion as no later than February 1, 2013, the
6 deadline for Plaintiffs' Replies to Oppositions to the Motion as no later than February 15, 2013,
7 and the hearing on the Motion for March 7, 2013'

9 WHEREAS, on January 28, 2013, Katten Muchin Rosenman LLP ("Katten") notified
10 Plaintiffs it was entering the case as lead counsel for defendants Hansen Medical, Inc., Frederic
11 H. Moll, Steven M. Van Dick and Gary C. Restani (with Christopher Sells, "Defendants");

13 WHEREAS, Defendants requested, and Plaintiffs agreed, to delay the deadline for filing
14 Oppositions to the Motion for ten days in order to allow time for Katten to participate in the
15 drafting of the Oppositions to the Motion;

2 available date thereafter.

3 3. The March 21, 2013 hearing on Plaintiffs' Motion shall be vacated.
