**STIPULATION FOR DISMISSAL OF
ENTIRE ACTION WITH PREJUDICE;
ORDER**

1 Pursuant to Federal Rule of Civil Procedure 41(a)(1), Plaintiff MARIA BELEN FUENTES and
2 Defendants COUNTY OF NAPA, CITY OF AMERICAN CANYON, AMERICAN CANYON
3 POLICE OFFICERS NICOL DUDLEY, CHRIS ROBERTS, GEOFFREY ROCHESTER and
4 SERGEANT MIKE COLLINS, by and through their counsel of record, respectfully submit the present
5 Stipulation dismissing Plaintiff's Complaint in Case No. C09-05122 SBA. The parties further agree
6 that Plaintiff and Defendants shall bear their own costs associated with the maintenance and defense of
7 Case No. C09-05122 SBA.

8 THEREFORE, THE PARTIES HEREBY STIPULATE AND AGREE AS FOLLOWS:

18 other remuneration emanating out of this action as a result of the instigation, prosecution, defense or
19 dismissal with prejudice of Case No. C09-05122 SBA.
