 18 **COMES NOW** PLAINTIFF NATALIE JO, DEFENDANT MOBILE MONEY
 19 VENTURES, LLC, AND DEFENDANT STEVE KIETZ, by and through their
 20 respective counsel, to stipulate as follows:

21 1. On December 15, 2009, the Court issued its Order
 22 Setting Initial Case Management Conference And ADR Deadlines in
 23 this case ("CMC Order").

24 2. In response, Defendants filed a Motion to Compel
 25 Arbitration, which is currently pending before this Court.

1 3. On April 2, 2010, the parties to this case engaged in
2 an all-day mediation before mediator Mark Rudy.

3 4. At the conclusion of the April 2 mediation, Mr. Rudy
4 requested that the parties agree to a "one-week moratorium"
5 insofar as he intends to continue in his efforts to resolve this
6 case by continuing to meet with the parties.

7 5. The parties hope to know by April 9, 2010 whether an
8 early negotiated resolution of this case is likely.

9 6. The Court's CMC Order requires the parties to meet and
10 confer by April 6, 2010 with respect to initial disclosures,
11 early settlement, ADR process selection, and the discovery plan.
12 The CMC Order further requires the parties to file certain
13 pleadings with respect to ADR on April 6, 2010.

14 7. Given the current status of settlement negotiations,
15 and Mr. Rudy's request for a one week moratorium, the parties
16 stipulate and agree to extend all deadlines currently set for
17 April 6, 2010 to April 19, 2010.

18 8. The parties further agree to extend the deadline for
19 initial disclosures, and filing of the Rule 26 Report and Case
20 Management Statement, currently set for April 20, 2010, to May
21 4, 2010.

22 9. The parties agree to move the Case Management
23 Conference currently set for April 27, 2010 to May 11, 2010.
24 Counsel for Plaintiff has cleared the new date with the clerk.
