- 2 being duly sworn by the Certified Shorthand Reporter
- 3 to tell the truth, the whole truth, and nothing but
- 4 the truth, testified as follows:
- 5 EXAMINATION BY MR. CLARK
- 6 Q. Okay. Good afternoon. My name's Perry
- 7 Clark. I'm a lawyer. I represent Petroliam Nasional
- 8 Berhad which I will refer to as Petronas which is the
- 9 plaintiff in this case.
- 10 MS. KLAUSNER: And I'm Tonia Klausner
- 11 with Wilson Sonsini on behalf of Go Daddy.
- 12 BY MR. CLARK:
- 13 Q. All right. So would you please state
- 14 your name for the record and spell it please?
- 15 A. Matthew Bilunes. First name
- 16 M-a-t-t-h-e-w. Last name Bilunes, B-i-l-u-n-e-s.
- 17 Q. Okay. And what's your job title at Go
- 18 Daddy?
- 19 A. Supervisor, Domain Services.
- 20 Q. And what are your responsibilities as a
- 21 Supervisor of Domain Services?
- 22 A. Currently working with our customers to
- 23 acquire their domain names which are registered to
- 24 them. At this time, just recent -- well, just
- 25 recently I've taken that job as a -- for training, a

- 1 momentary training. Usually my job is to work with
- 2 domain names that are under proceedings of court or
- 3 ICANN approved arbitration forums.
- Q. Okay. And so how long have you worked at
- 5 Go Daddy?
- 6 A. I've been at Go Daddy since December of
- 7 2005.
- 8 Q. Okay. And how long have you been working
- 9 on matters related to domain disputes?
- 10 A. I would say that would be approximately
- 11 March or April of '08.
- Q. And who's your supervisor or manager
- 13 right now?
- 14 A. My current supervisor's name is Pam Bunn,
- 15 but that's only recently. My supervisor until
- 16 recently was Laurie Anderson.
- 17 Q. Okay. And is there any reason -- do you
- 18 know why -- any reason for the switch in managers?
- 19 Was there a reason?
- 20 A. Oh, it's a cross-training to get other
- 21 people experienced in what I do just in case I no
- 22 longer work at Go Daddy in the future so they won't
- 23 be left with people who don't know as much as I do.
- Q. Okay. So you have been designated on two
- 25 topics. Actually, if you could grab Exhibit 1,

- 1 please, from the pile in front of you. And if you
- 2 turn to numbered page 8 -- I'm sorry, 7. There's a
- 3 numbered paragraph there. And do you understand that
- 4 you've been designated as Go Daddy's representative
- 5 on topic number 1 on page 7 in Exhibit 1?
- 6 A. Yes, I understand that I've been
- 7 designated.
- 8 Q. Okay. So can you tell me how many
- 9 incoming trademark complaints Go Daddy received in
- 10 2010?
- 11 A. I cannot give you an approximate number.
- 12 Q. You can give me an approximate number?
- 13 A. Cannot.
- Q. Can you give me an approximate number for
- 15 2009?
- 16 A. No, I cannot.
- 17 Q. If you wanted to find out the number of
- incoming trademark complaints that Go Daddy had
- 19 received for any specific period of time, how would
- 20 you go about doing that?
- 21 A. I would consult with our trademark claims
- 22 people who handle the trademark complaints.
- Q. Okay. And before your deposition today,
- 24 did you consult with any of the people who handle the
- 25 trademark claims?

- 1 Q. Okay. And so what is the trademark
- 2 policy with regards to the domain names themselves?
- 3 A. The policy there, the UDRP as it is
- 4 called is that if someone disputes someone's
- 5 registration of a domain name, you know, we cannot
- 6 take action on the domain name until we have been
- 7 ordered by ICANN approved arbitration forum or a
- 8 court in a competent jurisdiction, if we are
- 9 contacted.
- 10 And we will maintain the status quo as is
- 11 part of the policy which would mean locking the
- domain name, preventing any further modifications to
- 13 it, not disabling the site, but preventing further
- 14 changes to registration, changes to the name servers
- 15 or where other hosting is pointing to.
- 16 And then in the future when we are
- 17 provided a filed court order or a decision from one
- 18 of these arbitration forums, we'll follow it
- 19 accordingly as the policy describes how to implement.
- Q. Okay. Do you know what policy was
- 21 applied to the trademark claim submitted by Petronas
- in December 2009 to Go Daddy regarding the domain
- 23 name petronastower.net?
- A. I do not.
- Q. Okay. Do you know what policy was

- 1 applied to the trademark claim submitted by Petronas
- 2 in July 2010 related to the domain name
- 3 petronastowers.net?
- 4 A. I do not.
- 5 Q. Were you at all involved with Go Daddy's
- 6 handling of Petronas' trademark claim related to the
- 7 domain name petronastower.net?
- 8 MS. KLAUSNER: Can I just make an
- 9 objection to what you mean by claim. Do you mean
- 10 something that was to Go Daddy itself or a claim made
- 11 in court? I think the witness may be thinking of one
- 12 rather than the other.
- 13 BY MR. CLARK:
- Q. Okay. So let's -- why don't you go ahead
- 15 and take a look at Exhibit 9.
- 16 MS. KLAUSNER: It should be in order.
- 17 THE WITNESS: Okay.
- 18 BY MR. CLARK:
- 19 Q. I'm sorry, Exhibit 23. Two sets of
- 20 numbering. And why don't you take a look at Exhibit
- 21 23. And after you've done that, let me know if you
- 22 can tell me what Exhibit 23 is?
- 23 A. Could you repeat the question?
- Q. Yeah, sure. What is Exhibit 23?
- 25 A. Exhibit 23 appears to be submission of a
