1 Plaintiff Petroliam Nasional Berhad (“Petronas”) respectfully requests leave for its
2 party-representative to appear telephonically at the October 18, 2010 settlement conference
3 pursuant to the Court’s September 10, 2010 Notice of Settlement Conference and Settlement
4 Conference Order (Docket No. 68). The undersigned, plaintiff’s lead trial counsel, will appear
5 in person at the settlement conference and, should leave be granted, plaintiff will provide a toll-
6 free telephone number and any additional telephonic equipment necessary to facilitate the
7 requested telephonic appearance.

8 Petronas, the plaintiff in this trademark action, is a Malaysian oil and gas company with
9 headquarters in Kuala Lumpur, Malaysia. All of the personnel involved in this matter work in
10 Petronas’s headquarters in Malaysia and Petronas does not have any employees outside of
11 Malaysia that have any connection to this matter. The Petronas personnel involved with this
12 matter have not travelled and do not plan to travel to the United States in connection with this
13 matter or any other matter.


14 The flight-time for a one-way flight between San Francisco and Kuala Lumpur,
15 Malaysia is more than 31 hours and involves at least one stop. Round-trip, economy class
16 airfare for such flights typically exceeds USD \$1,500. Because San Francisco and Kuala
17 Lumpur are on opposite sides of the international dateline and because of the flight time
18 involved, a Petronas employee would need to allocate at least an entire work week away from
19 their offices in order to attend a one-day settlement conference in San Francisco.
