The complaint in this matter was dismissed in its entirety on September 9, 2010. Though
 no complaint is pending currently, there is a settlement conference scheduled for this matter on
 October 18, 2010.

On September 23, 2010, Plaintiff Petroliam Nasional Berhad ("Plaintiff") filed a request
for leave to allow its party representative to appear telephonically at the settlement conference.
Defendant GoDaddy.com ("Go Daddy") does not object to the request, as long as its party
representative or representatives are permitted to appear telephonically as well.

Go Daddy's corporate offices, and the corporate representative or representatives who
would be required to appear in this matter, are based out of state (in Scottsdale, Arizona).
Pursuant to the Court's order, Go Daddy is prepared to participate in the settlement conference in
person, particularly if Plaintiff will participate in person as well.

Go Daddy notes that Plaintiff purposefully chose the Northern District as the forum for this matter, even though Plaintiff is based in Malaysia, the registrant of the Internet domain name at the heart of this matter is in England, the party responsible for pornography posted in connection with the domain name is apparently in Switzerland, and Go Daddy is in Arizona.

16 If Go Daddy's company representative is required to attend the settlement conference in 17 person, then Plaintiff's representative, who is the driving force behind this litigation, should be 18 required to attend as well. If appearance by phone is acceptable for Plaintiff's representative, it 19 should be acceptable for Go Daddy's representative as well.

Go Daddy therefore respectfully requests that all party-representatives (including any
insurance company representative) be permitted to appear telephonically, or that all partyrepresentatives (including any insurance company representative) be required to appear in person
at the settlement conference.
