ORDER

Docket 123, 124

12 On May 28, 2013, Plaintiff filed a third amended complaint ("TAC"). Dkt. 120. On
13 June 24, 2013, Plaintiff filed a motion to compel Defendants to answer the TAC or, in the
14 alternative, motion for entry of default. Dkt. 123. On June 25, 2013, Defendant Chase
15 Bank USA, N.A. ("Defendant") filed a motion to strike the TAC. Dkt. 124.

16 Rule 15 of the Federal Rules of Civil Procedure provides that in all cases where, as
17 here, a party does not have the right to amend as a matter of course, "a party may amend its
18 pleading only with the opposing party's written consent or the court's leave." Fed.R.Civ.P.
19 15(a)(2). Accordingly, because Plaintiff did not receive Defendant's written consent or the
20 Court's leave to amend her pleading, the Court STRIKES the TAC from the record. See
21 Ready Transp., Inc. v. AAR Mfg., Inc., 627 F.3d 402, 404-405 (9th Cir. 2010) (courts have
22 the inherent authority to strike improper documents); see also Centillum Comms., Inc. v.
23 Atlantic Mut. Ins. Co., 2008 WL 728639, at *6 (N.D. Cal. 2008) (striking improperly filed
24 motion). This Order terminates Docket 123 and Docket 124.
