2 Plaintiff National Union Fire Insurance Company of Pittsburgh, Pa. ("National Union") and
3 Defendant NVIDIA Corporation ("NVIDIA") stipulate as follows:

4 WHEREAS, on June 25, 2010, Defendant NVIDIA Corporation filed a Motion to Stay
5 Insurance Coverage Litigation Pending Resolution of the NVIDIA GPU Litigation (*See* Doc. No. 20)
6 ("Motion to Stay"), which was originally scheduled for hearing on August 12, 2010;

7 WHEREAS, on July 11, 2010, the parties engaged in a mediation of their dispute, which
8 resulted in the parties agreeing on general terms to settle the above-entitled action; and

9 WHEREAS, the parties filed a stipulation on July 20, 2010 to continue the hearing on
10 Defendant's Motion to Stay for a period of two weeks, from August 12, 2010 to August 26, 2010, to
11 allow the parties time to finalize their settlement documentation;

12 WHEREAS, the Court granted the stipulation on July 22, 2010 to continue the hearing on
13 Defendant's Motion to Stay to August 26, 2010;

14 WHEREAS, the parties executed a settlement agreement resolving the above-entitled action
15 on July 29, 2010;

16 WHEREAS, the parties filed a Stipulation For Dismissal of Action with Prejudice in the
17 above-entitled action on August 4, 2010;

18 IT IS HEREBY STIPULATED between the parties, by and through their respective counsel,
19 that Defendant NVIDIA Corporation hereby withdraws its Motion to Stay and the August 26, 2010
20 hearing on the Motion to Stay shall be taken off calendar.
