AND ALL RELATED CLAIMS

1 Pursuant to the parties' stipulation of June 15, 2012 regarding entry of judgment and the Court's
2 Orders of July 25, 2011, February 1, 2012 and June 15, 2012,

3 IT IS ORDERED AND ADJUDGED

4 That judgment is entered for Plaintiff Adobe Systems Incorporated and against Defendants Hoops
5 Enterprise, LLC and Anthony Kornrumpf on Adobe's first and second claims for relief for copyright and
6 trademark infringement, and on Defendants' second counterclaim for violation of California's Unfair
7 Competition Law;


8 That Defendants' first counterclaim for declaratory judgment of copyright misuse is dismissed;
9 and

10 That Defendants are jointly and severally liable for actual damages in the amount of \$721,344.33
11 on Adobe's first claim for relief of copyright infringement only. Each party shall bear its own costs.

12 The Court has entered a permanent injunction by a separate order.

13 This judgment is subject to, and does not reflect waiver of, defendants' right to appeal all orders,
14 objections, opinions, and rulings issued in this matter.
