18 served with the Counterclaims and their response date to the Counterclaims, as filed, will remain
19 on November 30, 2010.

20 This Order will not alter, deprive or act as a waiver of any claims, defenses or rights of any
21 of the parties in this case and all related claims, all of which are expressly and respectively,
22 reserved.
